## WHAT YOU NEED TO KNOW ABOUT OVERDRAFTS AND OVERDRAFT FEES

An overdraft occurs when do not have enough money in your account to cover a transaction, but we pay it anyways.

WE can cover your overdrafts in two different ways:

- 1. We have standard overdraft practices that come with your account
- 2. We also offer <u>overdraft protection plans</u>, such as a link to share/shavings account or overdraft line-of-credit, which may be less expensive than our standard practices. To learn more, ask us about these plans.

This notice explains our standard overdraft practices.

What are the standard overdraft practices that come with my account?

We <u>do</u> authorize and pay overdrafts for the following types of transactions:

- Share draft/checks, and other transactions made using your checking account
- Automatic bill payments
- ACH transactions

We do not authorize and pay overdrafts for the following types of transactions unless you ask us to

- ATM transactions
- One-time debit card transactions

We pay overdrafts at our discretion, which means we <u>do not guarantee</u> that we will always authorize and pay any type of transaction.

If we do not authorize and pay an overdraft, your transaction will be declined

What fees will I be charged if The Credit Union pays my overdraft?

Under our standard practices:

- We will charge you a fee of \$25.00 each time we pay an overdraft
- There is <u>no limit</u> on the total fees we can charge you for overdrawing your account

What if I want the credit union to authorize and pay overdrafts on my ATM and one-time card transactions?
